Z. Ryzhikova «*Organizing and conducting surveys on selected aspects of employment, remuneration of labour and use of information technology and information-and-telecommunication networks by population*»

Keywords: state social policy, federal statistical observation, social and scientific workers, employment, remuneration of labour, information technology, information-and-telecommunication networks.

The author provides characteristics of the work done by statistical authorities in the current year on the creation of an information base for the monitoring of implementation of the government social programs. The article considers the problems of organizing the federal statistical observation on the number and labour remuneration of certain categories of social and scientific workers; organizational and technical framework for the collection and automated processing of the statistical observation materials; official statistical information presentation and presenting it to users; methodology for calculating the average wages by categories of workers, as well as the federal statistical observation of information technology and information-and-telecommunication networks usage by population.

O. Rybak «Methodological problems of measuring expected years of schooling»

The article focuses on substantial differences in expected years of schooling received after calculating performed in accordance to international and national practices; main causes of the quantitative discrepancies are presented. Typology of population groups for net and total education coverage ratio (enrollment ratios) use is proposed. The technique for determining and application of additional calculations coefficients of the number of students is developed. Organizational and legal issues of functioning of the national educational system, affecting the validity of international comparisons of expected years of schooling are identified.

S. Biryukova «Methodology for assessing the contribution of migrants to the reproduction of the population of Russia on the basis of the data from civil registry»

Keywords: methodology for assessing the contribution of migrants to the reproduction of the population, current population record, current fertility and mortality statistics, contribution of migrants to birth and death rates.

This article comments on the results of a pilot calculations of the contribution of migrants to the birth and death rates estimate in ten regions of the Russian Federation for 2009, derived from the current mortality and fertility statistics. Calculation methodology for the system of birth and death indicators - general and age-specific fertility and mortality rates for migrants and indigenous population - is suggested to compile this evaluation. The author claims that the results do not allow to make decisive conclusions on influence migration has on mortality and fertility indicators in Russia.
